TERMS AND CONDITIONS

- It is understood this Studio/Photographer is the exclusive official photographer retained to perform the photographic and/or video services requested on this Contract.
- Upon signature, Cutting Edge Images, Inc. shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, unless Cutting Edge Images, Inc. is able to fully replace the cancelled reservation, all retainers are non-refundable, even if the date of the wedding is changed or the wedding is cancelled for any reason.
- No part of any order, including previews, will be delivered until the balance is paid in full.
- Cutting Edge Images, Inc. reserves the right to use photographs and/or reproductions for advertising, display, publication or other purposes. Negatives, digital files and previews remain the exclusive property of Cutting Edge Images Inc. Please initial HERE _____ should you wish to opt out of this.
- Cutting Edge Images, Inc. may substitute another photographer to take the photographs in the event of Studio/Photographer's illness or of scheduling conflicts. In the event of such substitution, Cutting Edge Images Inc. warrants that the photographer taking the photographs or video shall be a competent professional.
- If Cutting Edge Images, Inc. cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness or emergency, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera or other media malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event Cutting Edge Images, Inc. fails to perform for any other reason, Cutting Edge Images Inc. shall not be liable for any amount in excess of all monies paid.
- Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
- Client is obligated to provide food/meal to the photographer and his assistant(s). The wedding day is extremely long and physically exhausting, and we need our fuel to provide you with the best images possible!
- The charges in this contract are based on the Cutting Edge Images, Inc.'s Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
- Please allow up to two weeks after your wedding for the unedited photographs to be posted on my website. Basic edits will be applied to these photos, but the Client will need to select their favorites to be edited further. A photographer/client consultation will take place in order for the client to select their favorites. Please note, all photos will have basic edits applied to them (brightness, color correction, and contrast), but any additional edits requested by the client (i.e., fixing double chins, removing people/objects from photos, skin touchups/blemish removal, black and white, etc.) will be surcharged at a rate of \$10/photo.
- NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs or videos elsewhere without Studio's/Photographer's permission, and violators of this Federal Law will be subject to its civil and criminal penalties.
- All photos posted on social media, printed, or otherwise distributed may not be done so without photographer consent if prior to full editing and distribution of said photographs to the client/signing party. If the signing party/client distributes photos, prints them, posts on social media, or otherwise distributes photos and/or files prior to receiving fully edited photos, the client will be charged accordingly for said photos. Legal action may be taken if client refuses payment.
- **Late Payment Policy:** All payments must be due IN FULL within **30 days** of the completion of your event unless otherwise worked out between Client and the Photographer. All late payments past that due date will be subject to an additional 10% charge on your remaining balance for every 30 days thereafter that full payment is not received. Please understand that contracting party is more than happy to work out a payment schedule if need be, however, this must be agreed to before the contract is first signed. **Please include your 20% deposit with the signed copy of this contract no later than 8 weeks prior to your wedding day to avoid the date being double booked.** Late payment of the deposit could result someone else taking your spot and your event not being booked.

Wedding Collections:

***** I will usually have either a second shooter or an assistant with me. The fee for this service is included in all package options. Travel OUT OF STATE/COUNTRY will be priced accordingly depending on where the wedding is. Every package except the engagement session package will include a personally designed museum quality photo album from Fundy. More information will be given during our consult.*****

Engagement Sessions Only (\$700): The engagement session will include a 2-hour shoot at the location of your choice, as well as a DVD of the edited images from the session (Does NOT include photo album).

Bouquet Collection (\$2,200): Includes 6 hours of wedding day coverage. This typically includes photo portrait sessions with the bride and groom both together and separately either before or after the ceremony, whichever you prefer. Getting ready and party photos are also included in this package if time allows. Additional time may be purchased at \$200/hour.

Ring Collection (\$2,700): Includes 8 hours of wedding day coverage, and 2-hour Engagement photo session at the location of your choice (with up to 3 outfit changes allowed as to ensure we have enough time to get to all the photos you would want).

Dress Collection (\$3,800): Includes 8 hours of wedding day coverage, DVD of images, 2-hour Engagement photo session at the location of your choice, and max 2-hour coverage at the rehearsal party.

“I DO” Collection (\$5,200): Includes 10 hours of wedding day coverage, DVD of images, Up to 3-hour Engagement photo session at the location of your choice, and max 4-hour coverage at the rehearsal party.

Digital Images DVD:

The Digital Images DVD will only be included in select package options, but can be purchased for an additional \$300 with your package.
